RTX Healthcare's Wireless Telehealth Gateway is now approved by the U.S. FDA and available to Healthcare Providers

Summary: The RTX3320 PSTN Wireless Telehealth Gateway is now a FDA approved wireless connectivity device for remote patient monitoring, creating what has been a missing link between standard wireless patient monitors, currently available, and any electronic patient health record managed by a healthcare provider.

The device provides immediate benefits to patients by utilizing advanced wireless and Internet technologies, implemented for operation with a minimum need for patient interaction.

RTX Telecom's subsidiary, RTX Healthcare, today announced that the U.S. Food and Drug Administration (FDA) has issued a 510(k) Premarket Notification Clearance to the Company for the RTX3320 PSTN Wireless Telehealth Gateway designed for home monitoring, e-health and remote disease management applications.

The device provides immediate benefits to patients by utilizing advanced wireless and Internet technologies, carefully implemented for seamless and automated operation with a minimum need for patient interaction to improve patient quality of life, convenience and compliance in their daily monitoring.

The RTX3320 PSTN Wireless Telehealth Gateway is a wireless Bluetooth-to-PSTN gateway designed for home use by patients. It is intended to be used in combination with a variety of patient monitors upon the prescription of a licensed physician or other authorized healthcare provider. Its purpose is to transmit selected medical information – such as weight, blood pressure or blood glucose levels – over a normal residential telephone line directly to the healthcare facility. The RTX3320 is fully compliant with the Health Insurance Portability and Accountability Act (HIPAA) of 1996, thus ensuring protection of confidentiality and security of patient health data.
